Various legal documents require that a person's signature is witnessed by a commissioner. You are therefore invited to familiarize yourself with the full legal framework relating to oath-taking before a commissioner, please consult the following link [Québec Ministère de la Justice](#). It is important not to sign the relevant document before meeting with the commissioner of oaths; **the document must instead be signed in front of the commissioner.**

#### The Municipality is reimbursing any extra fees required for non-residents to participate in recreation services provided by the Town of Sainte-Agathe-des-Monts

In order to assist families in the Municipality, a reimbursement for the extra fees charged by the Town of Sainte-Agathe-des-Monts for non-residents is possible for certain activities related to sports, recreation, and day camp services. ### Visits from wild animals

Are you getting visits from wild animals in your yard? Ah yes, it's possible, since we've chosen to live in an area where vegetation, forests, and rivers abound! You may run into wild turkeys, deer, and even coyotes here! Please be aware that they aren't usually dangerous. This is their home too don't forget!

However, if you notice any strange or dangerous behaviour, such as a wild animal coming too close to your house, you can contact the Ministère des Forêts, de la Faune et des Parcs (MFFP) directly at (819) 425-6375 and they will offer you solutions. Most of the time, the solution, especially for coyotes, is to trap them, so you should only use this solution as a last resort. If necessary, you can also contact the Municipality.

### Update on the ongoing files

Here is some information on the various ongoing files in our municipality:

- Municipal street cleaning mandate  
The street cleaning mandate has been granted, but since Mother Nature isn't really cooperating and the snow is currently still melting, the streets will be cleaned once as we are able to do so.
- Follow-up to the formal notice from the Association des pêcheurs sportifs du Québec  
A letter has been sent to the Association des pêcheurs sportifs du Québec to follow up on their request. The Municipality is now waiting for their response.
- Short-term rentals  
The Urban Planning Committee (*Comité consultatif d'urbanisme* [CCU]) will soon meet to review the short-term rental structures and analyze comparable situations within our region. If you would like to give your opinion on the restructuring of short-term rentals in our municipality (namely, whether you agree or disagree, the items you would like to see included, etc.), don't hesitate to share your feedback with us at [info@ivry-sur-le-lac.qc.ca](mailto:info@ivry-sur-le-lac.qc.ca) by the end of April 2018. The CCU will then meet to define the short-term rental framework, which will be presented to citizens at a town hall meeting before being officially adopted.
