Notice of Closing of Administrative Offices

Due to the Good Friday holiday, our administrative offices will be closed on Friday, April 2, 2021. Our team will be back to regular working hours on Tuesday, April 6, 2020.

Have you noticed that Easter is the only holiday that is not on a fixed date! Indeed, it can be in March or April, and one thing is certain, it is always on a Sunday.

There are three data points which help to establish the date on which Easter falls:

The spring equinox, which is the length of daylight equal to the length of night (darkness).

The full moon that follows

On the Sunday following this full moon

This year, the equinox will take place on March 20th and the full moon that follows will be on March 28th.

Accordingly, the following Sunday is April 4th!

You can also buy many products in local grocery stores during this sweet period to make their season a little sweeter!




New at Parc Éco Laurentides

Sûreté du Québec – Winter and Snowmobilers

The *Sûreté du Québec* asks for the cooperation of snowmobilers, so that they can engage in their sport in the appropriate places with respect and peace of mind for residents and the environment. Since the beginning of the season, police officers have been raising awareness among snowmobilers riding on private property and sometimes causing major breakdowns at certain facilities.

Snowmobilers who wish to ride off-trails must first find out where it is legally possible to do so in the area.

It is also necessary to be familiar with the provisions of the Off-Road Vehicle Act before venturing out.

Police officers conduct surveillance operations in order to target drivers in violation not only of the Highway Safety Code, but also of the Criminal Code.

The *Sûreté du Québec* would like to remind you that impaired driving and speeding have been the main causes of fatal collisions in recent years.



RIDM Adapted Relief Program

The Régie Incendie des Monts (RIDM) is continuing the Programme de Secours Adaptés for people requiring special assistance for evacuation in case of fire. This program is intended for people with a permanent limitation (auditory, intellectual, motor or visual), which could have an impact on their ability to evacuate their home.

The information gathered through the program allows 911 dispatchers to notify the vehicle en route and ensure an appropriate response.

Please note that the information collected as part of the program remains confidential and is only used in emergency situations requiring evacuation of the home.

Shoreline Residents – There is water on my property, what should I do?

It is normal, during snowmelt, to have an accumulation of water along the edge of the lake due to the higher lake level and the increase in water table and river flows. The absorption capacity of the land is therefore diminished during this period.

If, on the other hand, you notice that the presence of water on your land persists, several factors must be considered and climate change plays a significant role in the evolution of the water table and its behaviour.

If you wish to improve your situation, it is recommended that you refer to a professional, who, through a study they will carry out, will be able to offer you an action plan to improve the natural drainage of the water present. There is no need to refer you to the Municipality, this is not an area of municipal expertise.

If the action plan involves work at or near the shoreline, within fifteen (15) meters of the shoreline from the Highwater mark, you must consult the Municipality at this stage, to obtain a certificate of authorization from the Urban Planning Department before starting the work.

The urban planning department will analyze your request and ensure that the work to be carried out complies with municipal regulations.

Snow on my roof, how should I proceed?

The amount of snow accumulating on the roof will vary depending on the position of the house in relation to its environment. In some cases, it may never need to be removed. In the event that snow accumulation is significant, particularly during periods of thaw or during an ice storm, the load increases considerably and the natural drainage of the roof may be compromised by ice formation, thus requiring certain steps to be undertaken.

The *Régie du bâtiment du Québec*, as a preventative measure and as well as for everyone's safety, recommends the following measures to homeowners:

- Remove the snow accumulated on their property to avoid the risk of collapse.
- Take the necessary measures to ensure the safety of people walking near the building.
- Pay attention to snow loads on vaulted or rounded roofs, especially if these loads are not evenly distributed.
- Entrust snow removal to qualified companies with the appropriate expertise and equipment.



By entrusting this task to companies with the appropriate methods and equipment, you avoid damaging the waterproof membrane of the roof. However, should you decide to remove the snow from the roof yourself, it is recommended that you do so **from the ground**, using a roof shovel equipped with a telescopic handle to prevent any risk of falling. Keep in mind that the operation consists of removing the excess, leaving a layer of 10 to 15 cm to avoid damaging the roof.

Signs of risk of collapse;

- Appearance of cracks on the walls
- Interior doors that jam or rub when opening or closing
- Unusual crackling noises are heard
- Ceiling distortion
