News from your municipality

Municipal General Election

The Municipality of Ivry-sur-le-Lac had 494 electors registered on its electoral list this year and of this number, 329 valid votes were counted. The participation rate was 66.6%. On Sunday, November 7th, voters elected Mayor André Ibghy and Councillor Julia Bourke.

Your City Council for the next four years will consist of:

Mr. André Ibghy, Mayor, elected on November 7th, 2021

Mrs. Julia-Ann Wilkins, Councillor seat no. 1, elected by acclamation

Mr. David Lisbona, Councillor seat no. 2, elected by acclamation

Mrs. Gabriela Opas, Councillor seat no. 3, elected by acclamation

Mrs. Julia Bourke, Councillor seat no. 4, elected on November 7th, 2021

Mr. Maxime Arcand, Councillor seat no. 5, elected by acclamation

Mr. Jean-Pierre Charette, Councillor seat no. 6, elected by acclamation

The number of women elected has increased from one to three for the current council! In addition, the council is well diversified, notably with a good representation of people 55 years and under.

Year 2021 Achievement Report

Several grants confirmed in 2021

 Local Road Assistance Program – Acceleration and Realignment Component (\$635,019 for 2021 renovation work)

Achievements through this program

(some works are subsidized at 50% while others at 75%)

- Replacement of certain sections of pavement and the reprofiling of ditches on Lac-de-la-Grise Road
- o Pavement replacement and the reprofiling of ditches on all of Lac-Azur Road
- o Renovation and granular resurfacing of the entire Vallée-Manitou Road
- o Replacement of several culverts on the territory
- Local Road Assistance Program Specific Projects Component Accorded by Constituency (\$15,000 for 2021 renovation work)

Achievements through this program

This program allows for the reimbursement of up to 60% of the costs for tree removal work in the public right-of-way that took place during the spring of 2021, thereby ensuring better public safety.

Load Road Assistance Program – Maintenance Component

(\$4,166 for maintenance work on our road network in 2021)

Transport Canada Boating Safety Contribution Program

This program which permitted several initiatives last year, notably the acquisition of a boat, the implementation of a nautical patrol, the printing of nautical subject flyers, the design of a nautical code, the production of signs, etc., plus the program continued this year by covering the costs related to the nautical patrol and the printing of nautical flyers.

This financial assistance is granted up to and including 2022.

Canada Summer Jobs Program

(Grant of nearly \$5,500 for 2 students, for the washing station and road maintenance workers)

This program allowed for a subsidy for the student's salaries.

In summary, the Municipality of Ivry-sur-le-Lac has received nearly \$700,000 in additional grant revenues for 2021, which has allowed us to prioritize certain projects without increasing our taxes!

Opening of the Washing Station

The main objectives of the washing station are to preserve the environmental quality of the aquatic environment and the shoreline and to prevent the introduction of invasive exotic species.

The second year of the washing station's activities was a great success and was appreciated by all! Almost 600 decals were issued in 2021 compared to 327 decals issued in 2020. In addition, 363 decals were issued for non-motorized boats, including kayaks of non-residents who had to have their boats washed and pay to access to the landing. Of course, there were many more washes since each decal included unlimited access to the washing station.

Except for non-motorized kayaks that had to be washed before each launch, we only had one motorized boat launched by a non-resident who paid the \$250 fee.

In order to ensure everyone's satisfaction, the administrative team sent a notice in the spring to all citizens who had already registered a boat the previous year so that they could be well informed regarding the standards to be respected before each launch.

In addition, a notice was sent to all known boat dealers in the area to make them aware of the obligation to wash each boat and trailer.

Thank you for your collaboration in prioritizing the health of the water bodies on the territory!

Shoreline regulation compliance

The process of ensuring compliance for all shorelines included the following measures:

- 77 inspections and the inventory of all non-compliant shorelines, documented with photos for each inspection file
- Personalised awareness letters, including photos and an accompanying pamphlet, sent to all citizens with a non-compliant shoreline
- Personalized awareness letters, including the explanatory brochure and regulations, sent to all gardeners/landscapers working in the area, in to advise them of the regulations in effect
- Opportunity to meet with the assistant inspector in the field, which occurred with many citizens.

Up to now, we have been able to depend upon the excellent cooperation of the citizens and we thank you very much. As you are surely aware, a well-managed shoreline has a very positive impact upon a body of water and represents its filtering lungs, while a non-conforming shoreline represents important risks.

A re-inspection is scheduled for early summer 2022 and citizens who do not comply are at risk to receive a Notice of Infraction. Although we do not wish to issue such a notice, the objective is to work with you to ensure that all shorelines comply with environmental standards and regulations. Please note that there is no grandfathering of landscaping. The administrative team and the municipal council have been taking steps to ensure the conformity of waterfronts since 2019!

COVID-19 Administration of a booster dose for persons 80 years of age and older

The Centre intégré de santé et de services sociaux des Laurentides wishes to inform citizens that as of Tuesday, November 16, 2021, people aged 80 and over living at home can make an appointment to receive a booster dose of the COVID-19 vaccine. An interval of six (6) months or more since the last dose was administered is required.

Abrinord

Abrinord is one of the 40 watershed organizations officially recognized by the Quebec government in the Act to affirm the interconnected nature of water resources and promote better governance of water and their associated environments. The organization is responsible for planning and coordinating the integrated management of water in the areas entrusted to it. Founded in 2003, Abrinord is a consultation and planning consultation vehicle, whose primary mandate is to develop a Water Master Plan (WMP), to update it, and to promote and monitor its implementation.

Abrinord is soliciting citizens to complete a survey. The information gathered through the survey will allow us it to make recommendations to optimize the municipality's adaptation to the risks presented by extreme weather events caused by climate change.


2021 Vaccination against the flu (influenza)

Flu vaccination is now open.

The Direction de la santé publique des Laurentides and the Direction de la vaccination contre la COVID-19 of the Centre intégré de santé et des services sociaux (CISSS) des Laurentides would like to inform the population that the campaign against the flu began on November 1, 2021 in the Laurentian region.

According to experts, vaccination is the best protection against complications from the flu. Influenza can be debilitating and cause serious consequences for people at high risk of hospitalization. In light of the recommendations of experts from the *Institut national de la santé publique du Québec*, vaccination is strongly recommended and offered free of charge to people who are at greater risk of developing complications.

This year, because of COVID-19, certain measures must be taken to ensure the health and safety of the population. Clients targeted by the flu vaccination must make an appointment online at www.clicsante.ca or by phone at 1 888 664-2555.



Waste management - Disposal of your bins!

When should I put my bins out?

To avoid breakage of your bins, especially during the cold season, it is important that they be placed not earlier than the day before collection and removed as soon as possible after collection. With the heavy machinery that clears snow from the roads, the bins can be damaged or buried. The Municipality of Ivry-sur-le-Lac is not responsible for damage caused by snow removal trucks.

How should I position my bins for collection?

Bins should be located at the curb, with the handles facing the house, so that nothing interferes with the collection, as close as possible to the outside line of the road, at a maximum distance of one metre. A minimum space of sixty (60) centimetres is required between each bin to ensure access.

Leaving for the cold season?

Be sure to store your bins in a location that does not indicate that the residence is uninhabited to potential thieves.



Reopening of the regional ecocenter!

The regional ecocenter located at 1710 Principal Street East, in Sainte-Agathe-des-Monts is once again open following expansion work! The facility had been closed since March 22, 2021 to allow for major expansion and optimization work.

Reminder of the improvements made

The work carried out will allow the increase of the facility's scope of services, by increasing the volume of materials recovered and by improving their recovery rate while promoting reuse, recycling and recovery in a hierarchical manner. The ecocenter has tripled its surface area, allowing for the addition of 20 new drop-off areas and the construction of a new building for recycling. There will also be a clear improvement in the management of certain materials such as wood waste. All this while ensuring efficient and safe traffic and operations for users and public works. Thus, accessibility will also be improved thanks to a greater fluidity of movement.

The MRC des Laurentides' network of ecocentres is THE means to achieve the objectives of the Residual Materials Management Policy aimed at eventually eliminating residue. This very important service not only contributes to the protection of the environment, but also to the green economy of the entire region!



Message from the MRC des Laurentides

The MRC des Laurentides wishes to warn citizens about scam artists who seek to enter homes.

Scam artists are currently posing as MRC des Laurentides inspectors in order to enter homes under the pretext of conducting a home inspection for property assessment purposes.

It is important to know that during the pandemic, the MRC des Laurentides's property assessment inspectors do not conduct interior visits of residences. A public communication will be made once they resume.

New triennial assessment roll for 2022-2023-2024

The new triennial assessment roll has been delivered to the Municipality of Ivry-sur-le-Lac, to be effective for the 2022, 2023 and 2024 fiscal years.

In accordance with the provisions of Section 74 of the *Loi sur la fiscalité municipale*, any person who has an interest in contesting the accuracy of its content is given notice, be-it the presence or absence of an entry on the assessment roll, or with respect to a property of which he or she or another person is the owner, may file an application for review as provided for in Section I of Chapter X of this Act.

To be admissible, such an application for revision must meet the following conditions

- be filed on or before April 30, 2022;
- be filed at or sent by registered mail to the following location:

Municipality of Ivry-sur-le-Lac 601, chemin de la Gare Ivry-sur-le-Lac, Quebec J8C 2Z8

- be made on the form prescribed for this purpose and available at the above-mentioned location
- be accompanied by the amount of money determined by the MRC des Laurentides by-law 313-2015 and applicable to the unit of assessment covered by the request.
