CULVERTS - DRIVEWAYS

ENVIRONMENT MULCH DISTRIBUTION - REMINDER

TEMPORARY WINTER SHELTERS



Time is flying by! Cold weather will take us by storm in a few months and we want to remind you that a temporary winter shelter is permitted in all setbacks and the parking area, as stipulated in bylaw 2013-060 (administratively consolidated bylaw) sections 206 and 368, starting October 1. The shelter must be removed no later than May 1, 2024.

ENVIRONMENT – SEPTIC TANK EMPTYING - REMINDER



CITIZEN'S OBLIGATION TO PROVIDE PROOF OF EMPTYING

According to article 4 of by-law 2009-131, when you have your septic system emptied, it is your responsibility to send proof of completion of the work to the municipality by October 15 of each year in which emptying is required by the by-law.

Although various service providers offer to send proof to the municipality, we never receive them all. It's best to send it to us yourself by e-mail (admin@ivry-sur-le-lac.qc.ca),

where we'll confirm receipt and update your file.

An annual maintenance contract is required for certain septic systems (Ecoflo, Bionest, Enviro-Septic, etc.). The same applies to annual maintenance. Send us proof to update your file. We accept a copy of the maintenance contract. Under section 4 of By-law 2009-131, when you have your septic system pumped out, it is your responsibility to submit proof of completion of the work to the municipality no later than October 15 of each year in which pumping is required by the by-law.

ENVIRONMENT – INVASIVE PLANTS



INVASIVE PLANTS, A THREAT TO BIODIVERSITY AND NATIVE SPECIES IN QUEBEC

Invasive plants are present in our gardens and in the natural spaces around us. Find out why we shouldn't plant them and why we need to eliminate invasive plants in Quebec....

Invasive plants are part of the large family of invasive alien species, which includes: plants, animals and microorganisms that establish themselves outside their natural range and pose a threat to the environment or society. Unlike native species, which occur in the natural environment without intervention, an exotic species has been introduced by human activity, either deliberately or accidentally. Exotic plants have been introduced to Quebec for decades in a variety of ways, including as ornamental plants, for agricultural purposes, during the transportation of goods or, in the case of marine species, by ships.

Some ornamental plants used in flowerbeds tend to invade the surrounding area. These can also be called invasive plants, as you may find it very difficult to control their growth, with some becoming veritable eyesores.

You'd think that adding plants to your flowerbeds wouldn't have any major consequences, and that you'd simply remove them if they don't suit you, but the reproductive capacity of some plants may surprise you! To avoid spending many gardening hours managing the growth of an invasive plant, it's best to take the time to find out about this important characteristic when buying unfamiliar plants, as it's not always indicated on the label of plants sold in nurseries.

Key characteristics of invasive plants and their impact

According to the World Conservation Union, alien species are the second greatest threat to biodiversity after habitat loss. Invasive plants pose a major threat to our ecosystems by altering animal habitats, displacing native plant species, hindering forest regeneration and causing major problems for farms and waterways. Their impact can also be felt on human health, in the case of plants such as poison ivy or, even more so, Giant Hogweed, which causes serious skin ailments. Invasive plants also pose a financial threat, with management and eradication work requiring substantial budgets, and their presence can even affect the real estate value of land or a home.

BURNING DEAD LEAVES IS NOT RECOMMENDED!



Every autumn, the Société de protection des forêts contre le feu (SOPFEU) and municipal firefighters respond to around twenty forest fires. The burning of dead leaves and other residues is largely responsible for these fires. To avoid unfortunate situations, SOPFEU recommends opting for safe, ecological solutions.

Prepare lawn fertilizer:

- Mow leaves for shredding;
- - Spread residues on the ground so that they hide in the lawn.

Protect plants from winter:

- - Pick up dead leaves quickly to prevent them from rotting;
- Place piles around plants so that air can circulate easily;
- Use nylon netting in windier areas to keep fallen leaves in place.

Enriching compost:

- Collect leaves before they become too wet and black-spotted;
- Shred plants so they decompose quickly
- Place surplus in bags for storage and use later in the year

Use the green waste collection system:

- Choose this option if the others are not possible;
- Check your municipality's recycling schedule;
- Find out how to dispose of your fallen leaves for easier collection (garbage cans, reusable rigid containers, biodegradable bags, etc.)Source: https://sopfeu.qc.ca/communiques/le-brulage-des-feuilles-mortes-cest-non/

SÉCURITÉ INCENDIE – THE DAY OF THE SMOKE ALARM TEST!





A new provincial and pan-Canadian event: "Smoke Alarm Test Day" on Thursday, September 28, 2023!

Quebec, along with all the provinces, will be taking part in the first "Smoke Alarm Test Day". The goal of this prevention activity is to create a ripple effect, encouraging citizens to take action by checking their smoke alarms on September 28.

Pourquoi participer à l'événement?

Raising public awareness of the importance of checking smoke alarms is essential to fire prevention. Smoke alarms are still the best way to save lives! Yet statistics on the fire situation in Quebec for 2019-2020 show that a large number of Quebecers still don't have a working smoke alarm. In fact, more than 31% of residential buildings damaged by fire in Quebec did not have a working smoke alarm. In addition:

- On average, one Quebecer loses his or her life every week in a building fire;
- And more than 14 homes are damaged by fire every day.
