Relevant information for the 2024 season.

Annual fee for owners and renters (with proof of lease of at least 3 months) of Ivry-sur-le-Lac.

Motorboat 9.9 hp (horsepower) or less Free

Motorboat over 9.9 hp \$80

Personal watercraft of all types \$120

DAILY RATE: Any user of a municipal waterway who does not hold an annual pass must obtain a daily pass at the rate set below.

Non-motorized boat \$20 per day

Motorboat with 9.9 hp or less \$150 per day

Motorboat over 9.9 hp \$250 per day

Fees may be paid by Interac transfer (use the following address: comptabilite@ivry-sur-le-lac.qc.ca), cheque or debit at our offices.

Don't forget to send us a copy of your Transport Canada registration certificate for your motorboat. It has an expiry date, so make sure you renew it so you always have a valid document in your boat when it's on the water.

SCHEDULE

From opening* to July 1, 2024 7 days from 8:30 a.m. to 4:30 p.m.

July 2 to August 31, 2024 5 days/week Wednesday to Sunday, 8:30 a.m. to 4:30 p.m.

September 1 to October 26, 2024 7 days from 8:30 a.m. to 4:30 p.m.

*Opening will take place no later than the weekend of May 18-20, 2024. Weather permitting, we will keep you informed.

Hours may vary, without notice, depending on the availability of human resources assigned to the landing and carwash stations, and on traffic during the season.

SEPTIC SYSTEMS

A new municipal bylaw concerning septic installations came into force on June 20, 2023, bylaw 2023-155 concerning the Management of septic installations. This involves new standards and requirements for owners of septic systems. Since January, the municipality has been working on a review of all septic systems on its territory. Communications are therefore being sent to citizens affected by the new regulations, following the review of their files. This communication is intended to be informative and is sent at the beginning of the year to give you the time you need to comply with the regulations. It is therefore important to take the necessary steps to avoid complying with the regulatory requirements, otherwise you will be committing a violation of the by-law concerning the management of septic installations, for which you could be liable to penalties.

In addition, provincial law Q2 r-22 on septic systems states that an annual maintenance contract is required for certain septic systems (Ecoflo, Bionest, Enviro-Septic, etc.). Many qualified professionals ask you to pay the annual fee by the end of March, in order to renew the agreement for the current year. Don't forget to forward a copy of the contract to the municipality, so that your file is up to date.

REMINDER OF BY-LAW 2020-118 – CONCERNING DOG CONTROL

Any dog kept outside its owner's occupancy unit must be held or restrained by means of a device (chain, cable, fence, enclosure, etc.) preventing it from leaving its outbuildings.

It is forbidden at any time to let a dog roam in a street, alley, public square or on private property other than the occupancy unit and outbuildings of the dog's owner.

A dog must be carried or led by its keeper on a leash not exceeding one metre eighty-five (1.85m) in length, except when the dog is within the limits of its owner's occupancy unit or outbuildings and is held or restrained by means of a device (chain, cable, fence, enclosure, etc.) preventing it from leaving its outbuildings.

Outside the boundaries of its outbuildings, a dog weighing 20 kg or more must also wear a halter or harness attached to its leash at all times.

It is forbidden to transport a dog, tied or untied, in the open box of a pickup truck. No dog may be confined in an enclosed space without adequate ventilation, and no dog may be left unattended in an automobile.

At all times, dogs must have access to water, well-drained soil and shelter to protect them from heat, cold and bad weather, and be free of bulky or dangerous objects.

As announced on January 2024 newsletter, the town of Sainte-Agathe-des-Monts has adopted draft by-law 2024-M-371 concerning the pricing of municipal services, including recreation services. This new by-law now includes the citizens of Ivry-sur-le-Lac, part of the agglomeration of Sainte-Agathe-des-Monts.

By purchasing the Agglomération - Sainte-Agathe-des-Monts citizen card, you will benefit from the same rates as Sainte-Agathe-des-Monts residents.

The rate is valid for all activities offered at the Centre sportif Damien-Héту, such as swimming lessons, open swim, field hockey, figure skating lessons and open skating. The card also includes free access to the Gaston-Miron library, the Le Bel Âge community hall and the Pierre-Fournelle ball field.

Ivry-Sur-Le-Lac residents will also enjoy free access to the three outdoor pickleball courts (Parc Lionel-Groulx, Parc du Mont-Catherine and Stationnement de la Plage Major), as well as indoor pickleball at Fleur-des-Neiges school.
