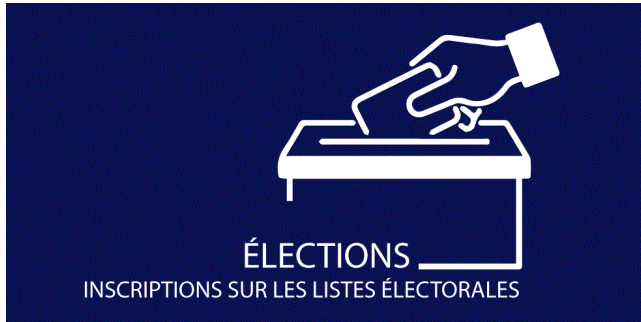


Composition of the municipal council

The council is made up of 1 mayor and 6 councillors.

The municipality of Ivry-sur-le-Lac is not divided into electoral districts. For the November 2, 2025 election, each elector will receive 7 ballots, one for each office, if more than one candidate has filed.





To be registered on the electoral roll and have the right to vote, you must meet all the following conditions by November 2, 2025:

- Be 18 years of age or older on polling day
- Be a Canadian citizen
- Not be under curatorship
- Not be under any legal incapacity to vote.

And meet one of the following two conditions:

- Be a resident of Ivry-sur-le-Lac and have been living in Quebec for at least six months
- Be, for at least 45 days :

Owner of a property located on the territory of Ivry-sur-le-Lac OR

Occupant of a business establishment located on the territory of Ivry-sur-le-Lac.

To be eligible to vote, your name must appear on the electoral roll.

Non-domiciled voters

- If you are not domiciled on the territory of the municipality of Ivry-sur-le-Lac, but have owned a building or occupied a business establishment for at least 45 days as of November 2, 2025, you may exercise your right to vote.
- If you are an undivided co-owner of an immovable or occupant of a business establishment, you must designate by proxy the person who is entitled to be entered on the electoral list.
- In both of the above cases, you must apply in writing to the returning officer to be entered on the list of electors. If you fail to do so, you will not be able to exercise your right to vote on polling day, as your name will not be entered automatically.
- Be sure to fill out the form that will be sent to you by mail or that will be available at [Élection 2025](#). Forms must be completed, signed and returned to the office of the returning officer before September 28, 2025.
- Please note that if you have applied for registration in the past, your application will remain valid until it is withdrawn or replaced.
- **Legal entities cannot vote in the election, even by proxy.**

Before submitting the electoral list - voter validation

Despite the constant efforts of the Chief Electoral Officer of Québec (DGEQ) to update the permanent list of electors, it is the elector's responsibility to ensure that he or she is correctly entered on the list.

Before filing the list of electors for the election, you can find out if you are registered on the permanent list of electors by visiting the DGEQ website at <https://www.electionsquebec.qc.ca/> .

After submission of the electoral list

- As of **October 6, 2025**, a copy of the list of electors will be available at the office of the returning officer, where you will be able to check whether you are registered.
- A reminder card containing all the information required to vote will be sent to each elector on the voters list. Please ensure that the information on the card is accurate and spelled correctly.

Please bring this card with you on polling day to facilitate voting.

Your name is not on the documents you received?

This means you're not on the voters' list.

If this is the case, contact the returning officer's office immediately to check whether you are eligible to vote.

If so, you must go to one of the dates on which the board of revisors sits to apply for registration.

The electoral roll and its revision



Your name is not listed?

You must go in person to the board of revisors to register or to correct your registration. The board of revisors may ask the applicant for any proof it needs to make a decision.

To register, you must provide your previous home address and submit two documents:

1. One showing your name and date of birth (birth certificate, health insurance card, driver's license or passport).
2. One showing your name and home address (driver's license, student card, telephone or electricity bill).

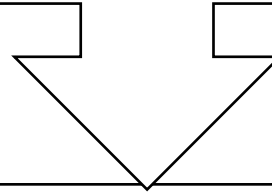

A person with reduced mobility who is domiciled in the territory and unable to travel for health reasons, or who is domiciled in a private residence for seniors in the municipality, may submit a written request for registration by mail to the election chair no later than October 21, 2025.

Exercising your right to vote



Mobile your right to vote

- A mobile advance poll will be held on Monday, October 27, between 9:30 am to 3:30 pm.
- Mobile voting is a new option for people with reduced mobility or who are unable to travel for health reasons. They can vote in advance at a mobile polling station if they are registered on the electoral roll as residents and have submitted a request by October 21, 2025, at the latest.

Advance voting

- An advance poll will be held on Sunday, October 26, 2025, from 12 pm to 8 pm.

Polling day

- The municipal election will take place on Sunday, November 2, 2025, from 10 am to 8 pm.

Mandatory prior identification



The elector must present an original identity card to the deputy returning officer before being allowed to receive his or her ballot. Voters must establish their identity by presenting one of the following documents:

- Health insurance card
- Driver's license
- Canadian passport
- Certificate of Indian Status
- Canadian Forces identification card

An elector who is unable to establish his or her identity in accordance with the preceding paragraph will be directed to the identity verification panel. He or she will then be required to present other documents to prove his or her identity, or to be accompanied by another person who will attest to his or her identity and present his or her own identification documents recognized by the Act.

Announcement of results

The polling station will close at 8 pm. Once the votes have been counted, the election results will be announced by the election chair and posted on the municipality's website under [Election 2025](#)

Important dates to remember

From September 19 to October 3	Submission of candidacy declarations, according to City Hall opening hours and from 9 am to 4:30 pm on Friday, October 3.
October 3	4:30 pm announcement of candidates elected unopposed, if applicable.
From October 3	A notice of revision explaining the procedure for revising the electoral roll, along with a registration card for each voter containing the information needed to vote, is sent to each address.
October 14 and 16	Last chance to request a revision of the electoral roll by appearing before the revision commission.
October 24	Entry into force of the electoral roll. Persons who are not registered on this list will not be able to vote.
October 26	Early voting from 12 pm to 8 pm
November 2	Election day from 10 am to 8 pm
