Have you filed your tax return?

Each year, many GIS recipients see their benefits interrupted in July because they have not filed their tax returns. In order to minimize these interruptions, clients are encouraged to file their tax returns electronically with the Canada Revenue Agency **before April 30**, or to complete a GIS renewal [form \(ISP3026\)](#) available on the Service Canada website.

Are you entitled to the GIS?

Yes, if:

- ✓ you are 65 or older
- ✓ you live in Canada
- ✓ you receive the [Old Age Security \(OAS\) pension](#)
- ✓ your income is below \$21,624 if you are single, widowed or divorced
- ✓ your income plus the income of your spouse/common-law partner is below:
 - ✓ \$28,560 if your spouse/common-law partner receives the full OAS pension;
 - ✓ \$39,984 if your spouse/common-law partner receives the Allowance;
 - ✓ \$51,840 if your spouse/common-law partner does not receive either the OAS pension or the Allowance.

You're not receiving the GIS?

Here's how you can:

- ✓ Apply online through a My Service Canada Account (MSCA).
- ✓ Complete a Guaranteed Income Supplement application [form \(ISP3025\)](#) available on the Service Canada website, and mail it to the nearest Service Canada office.

Clients must contact us as soon as their situation changes, for instance a change in income, marital status or address.

What is the Guaranteed Income Supplement?

The Guaranteed Income Supplement (GIS) is a monthly benefit that is not taxable and income-based. It is paid to Canadian residents who receive Old Age Security benefits and have low incomes. GIS benefits are renewed automatically each **each July, provided that the client files an income tax return by April 30.**

ENVIRONMENT – SEPTIC SYSTEM MANAGEMENT BY LAW

At the council meeting of March 17, 2025, by-law 2023-155-2 amending by-law 2023-155 concerning the management of septic installations was adopted. The following changes were made.

Article 4 - MANDATORY INSPECTION is amended as follows:

The frequency of septic system inspections will be determined by the professional's recommendations following the inspection. In the absence of any such specification by the professional, a subsequent inspection is required within a maximum of 24 months from the date of the last inspection.

Addition of article 4.9 - TRANSMISSION OF PROOF OF MAINTENANCE CONTRACT

According to article 3.3 of Q.2.r.22, the maintenance contract: The owner of a treatment system referred to in articles 11.1, 16.1, 87.7 or 87.13 must be bound at all times by a contract with the manufacturer of the system, his representative or a qualified third party stipulating that minimum annual maintenance of the system will be carried out.

Any owner whose septic system is subject to an annual maintenance contract with companies such as Premier Tech (Écoflo), Bionest & Enviro-septic, must send the municipality a copy of the annual contract no later than **May 1 of each year**.

Article 7 – Existing sump pit

The first paragraph of Article 7 is amended to read as follows:

As of January 1, 2024, all owners of isolated residences connected to a cesspool for wastewater disposal must provide a certificate of inspection every two years. The inspection must be carried out by a qualified professional.

PHASE 2 OF THE CONSIGNMENT PROGRAM



Phase 2 of the consignment program began on March 1. New containers now accepted

The objectives of Phase 2 are to recover and recycle a greater number of returnable beverage containers, and to find better ways to recover and recycle materials in order to reduce our ecological footprint.

The containers accepted for this phase 2 are ALL plastic ready-to-drink beverage containers from 100 ml to 2 l. This includes water, sparkling water and juice bottles, as well as all other beverages such as flavored water and spirits.

As you know, the Town of Sainte-Agathe-des-Monts has adopted draft by-law 2024-M-371 concerning the pricing of municipal services, including recreation services. This new by-law now includes the citizens of Ivry-sur-le-Lac, part of the Sainte-Agathe-des-Monts agglomeration.

By purchasing the **Agglomération - Sainte-Agathe-des-Monts** citizen card, **you will benefit from the same rates as Sainte-Agathe-des-Monts residents.**

The rate is valid for all activities offered at the Centre sportif Damien-Héту, such as swimming lessons, open swim, field hockey, figure skating lessons and open skating. The card also includes free access to the Gaston-Miron library, the Le Bel Âge community hall and the Pierre-Fournelle ball field.

Ivry-Sur-Le-Lac residents will also enjoy free access to the three outdoor pickleball courts (Parc Lionel-Groulx, Parc du Mont-Catherine and Stationnement de la Plage Major), as well as indoor pickleball at Fleur-des-Neiges school.
